Civil Societies take Rwanda to Court Over New Investment Promotion Code

The Tax Justice Network Africa (TJNA) and the East African Tax and Governance Network (EATGN) filed a case at the East African Court of Justice (EACJ) on 7 April 2021 challenging the enactment of a new Investment Promotion Code gazetted in February 2021 on the basis that it violates the East African Community (EAC) Treaty as well as other EAC laws. The Rwandan government has established the Kigali International Financial Centre (KIFC), which provides preferential treatment to investors through this law... Read full press release





Workplan Retreat with the Office of the Controller of Budget

Civil Society groups in collaboration with the office of the Controller of Budget (OCOB) held an engagement meeting to develop a joint workplan plan between the key organizations. This comes after NTA signed an MoU with the Office of the controller of budgets which commits them to work together with the OCOB to monitor use of public funds in-year; to strengthen the existing frameworks for budget monitoring and ensure that the national, county governments and their related agencies are held accountable to members of the public; as well as to contribute to the effectiveness in the provision of public service delivery.
