
## **UGANDA: CSO Position on the Tax Amendment Bills for FY** 2022/23


In April 2022, Uganda's Minister of Finance Planning and Economic Development tabled the Tax Amendment Bills, 2022 before Parliament for debate. The Bill captures proposals aimed at widening the revenue tax base such as changes to the Income Tax Act, The Value Added Tax, The Tax Procedure Code Act among others. As part of the annual tax process, CSOs under the Tax Justice Alliance Uganda submitted alternative tax proposals for FY2022/23 to the Ministry of Finance, Planning and Economic Development. Tax treaties are meant to serve the core function of encouraging cross-border trade by the elimination of double taxation likely to be caused by such trade. However, while treaties officially aimed at eliminating double taxation, they can also have the unintended consect of double non-taxation. This is because treaties can very easily be used as tools for aggretax planning that result in massive tax avoidance. Inflation is a process of sustained increases in the general price level over a period of time, typically 12 months. The phrase describing inflation as 'enemy number one' is borrowed from the research done by South African businessman Dr Anton Rupert on the 'worldwide inflation problem suffered in the 1970s'. Gender Mainstreaming is a globally accepted strategy for promoting gender equality. Mainstreaming is not an end in itself but a strategy, an approach, a means to achieve the goal of gender equality. Mainstreaming involves ensuring that gender perspectives and attention to the goal of gender equality are central to all activities policy development, research, advocacy/ dialogue, legislation, resource allocation, and planning, implementation and monitoring of programmes and projects.
