## Top EAC Stories to Keep an Eye on in 2024.

East Africa is poised for a dynamic and eventful year, with several key moments that are set to shape the region's political, economic, and social landscape. Here are some of the key events and developments to look out for:

- **Simmering Regional Tensions:** The East African Community (EAC) bloc is off to a rocky start in 2024 as trade and diplomatic tensions escalate, testing the region's unity to the fullest.
- **Presidential Elections:** Citizens in Rwanda and South Sudan are headed to the polls this year. The outcomes of these elections will have a significant impact on the future direction of both countries and the region at large.

- **Economic outlook**: Though economic growth in East Africa is expected to rebound in 2024, the region's economic outlook remains clouded by debt, lingering inflation, and climate risks, compounded by uncertainties on the political front.
- **Pan-African Payment and Settlement System:** The EAC launched the PAPSS platform in December, with Kenya the first country to go live. Full implementation across the region is expected by mid-2024 if foreign exchange rules and infrastructure challenges can be addressed.
- **Regional Integration**: The EAC has achieved notable milestones in regional integration, such as establishing a Customs Union, Common Market, and Monetary Union. Despite this progress, challenges persist, including infrastructure gaps, non-tariff barriers to trade, varying economic development levels, and political instability in some member states.
- Geopolitical relations: East Africa's relations with global powers, as well as
  with neighboring regions, will be under scrutiny in 2024 as the region seeks to
  balance its relations with China, the United States, Gulf states and other major
  powers. Competition for influence will likely intensify amid global
  uncertainties.
- Innovation and Technology: East Africa has been a hub for innovation and technological advancements, particularly in the areas of fintech and mobile money. Developments in these sectors, as well as advancements in digital infrastructure are expected in 2024.
